

Official Contest Rules – Winnin With Finnin Giveaway

The Company (Rainbow Oil Company) and its promotional partners (Mike Finnin Kia, Radio Dubuque and its stations: KDTH, WVRE, KAT-FM and KGRR) reserve the right to conduct contests in various forms which include, but is not limited to, in store, online, email, text, via the Company's kiosks, or via social networking accounts (e.g., Facebook, Twitter). Each participant must agree to the following rules to participate in the Winnin with Finnin Giveaway.

1. By participating in this contest, each participant agrees to waive any and all claims for damages for death, personal injury, loss of property or property damage that he or she may sustain as a result of his or her participation in the contest and/or the use of any prize, and any damages or losses arising from the implementation or for carrying out of the contest or any participant's failure to win the contest or receive the prize, and to release Kwik Stop, Dairy Queen, Fazolis, and the promotional partners identified herein and their parent companies, subsidiaries, affiliates, directors, officers, employees and agents from any and all liability arising out of or connected in any way with his, her or its participation in the contest, even though that liability may arise out of an intentional act, omission, negligence or carelessness on the part of the persons or entities mentioned above.

3. Only one (1) winner per household for the duration of each individual contest.
4. Rainbo Oil Company reserves the right to limit the number of times an individual may enter a contest or drawing.

Employees of Rainbo Oil Company, their immediate families and all promotional partners and their immediate families are not eligible to participate. **The term "immediate family members" includes, but is not limited to, spouses, parents, in-law's, siblings, grandparents, children, step children, grandchildren and significant others. 6. Unless otherwise specified, only legal U.S. residents who are 18 years of age or older with a valid Social Security number at the time of entry are eligible to participate in Company contests.
